## REGULAR MEETING – ATHENS TOWN BOARD – June 20, 2016

The regular meeting of the Athens Town Board was called to order on June 20, 2016 at 7:05 p.m. by Supervisor Robert F. Butler, Jr. with the Pledge of Allegiance to the Flag.

The following people were present: Supervisor Robert F. Butler, Jr.; Councilman Michael Ragaini; Councilman Anthony Paluch; Councilman Richard M. Surrano, Jr. and Town Clerk Linda M. Stacey. (Councilwoman Mary H. Brandow was absent.)

Attorney Virginia Benedict informed the Board that the owners of 51 Thorpe Road had applied for a building permit for a deck/dock over the pond and a gate to go across the stairs of the above ground pool. She suggested that Mr. Holsopple should get in touch with them and let them know that a Fireworks Permit is needed if they are going to be using fireworks. Discussion followed.
