## REGULAR MEETING - ATHENS TOWN BOARD - AUGUST 1, 2016

The regular meeting of the Athens Town Board was called to order on August 1, 2016 by Supervisor Robert F. Butler, Jr. at 7:00 p.m. with the Pledge of Allegiance to the Flag.

The following people were present: Supervisor Robert F. Butler, Jr.; Councilwoman Mary H. Brandow; Councilman Michael Ragaini; Councilman Anthony Paluch; Councilman Richard M. Surrano, Jr.; and Town Clerk Linda M. Stacey. (Highway Superintendent John J. Farrell was absent.)

<u>Interim Assessor Carol McBride</u> reported that two small claims have been filed to date. One Article 7 has been filed on the Sleepy Hollow Common Areas. There are 28 Town parcels and 6 Village parcels making a total of 34 parcels all together. These have been turned over to Attorney Benedict for review.

Mrs. McBride stated that Bob Hilbert, our consultant is planning on working in the office the third week of August, on the 2017 ReVal update.

<u>Carol stated that she wants to meet with Attorney Benedict</u> and the Board on what she learned at her recent assessor school in Ithaca, on what Towns that have similar "Communities" as Sleepy Hollow in their jurisdiction are doing as far as taxing the common areas. Discussion followed.

<u>Code Enforcement Officer George Holsopple</u> handed out copies of e-mails from Mary DiStefano of 15 Hidden Drive, Regarding the Air B & B on 51 Thorpe Road. He also spoke about Quarry Road.

<u>Attorney Virginia Benedict</u> read all the complaints from the Quarry Road Air B & B and stated that they are all Civil Issues. She asked for copies of the complaints so she could review them closer.

<u>Bookkeeper/ Budget Officer Michael Strenka</u> reported that he is getting the budget worksheets ready to handout to department heads. Discussion followed.
