## REGULAR MEETING - ATHENS TOWN BOARD - October 19, 2020

The regular meeting of the Athens Town Board was called to order by Supervisor Robert F. Butler, Jr. on October 19, 2020 at 7:00 p.m. with the Pledge of Allegiance to the Flag.

The following people were present: Supervisor Butler; Councilman Michael Ragaini; Councilman Anthony Paluch; Councilwoman Shannon Spinner and Town Clerk Linda M. Stacey. (Councilwoman Bandow and Highway Superintendent Farrell were both absent.)

The following bills were audited by the Board and ordered paid:

General Abstract #20, vouchers #353 through #380 inclusive for \$34,303.37.

Highway Abstract #20, vouchers #190 through #196 inclusive for \$2,495.41.

Attorney Virginia Benedict presented the Board with copies of proposed local law No. 1 for 2020 to override the tax levy limit for fiscal year 2021.

On the motion of Councilman Michael Ragaini seconded by Councilwoman Shannon Spinner the following RESOLUTION #2020-35 was adopted as follows:

**BE IT RESOLVED**, that Local Law No. 1 of 2020, providing for a local law to override the tax levy limit for fiscal year 2021, a copy of which is annexed hereto, is hereby introduced at this meeting.

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Athens as follows:

- The Town Board of the Town of Athens shall hold a public hearing on the 5 day of November, 2020, at 7:05 p.m. at the Athens Community Hall Gym, Athens, New York, to hear all interested parties on said proposed Local Law.
- The proposed Local Law constitutes a Type II action for purposes of the State Environmental Quality Review Act which will not require SEQRA review.
- The Town Clerk is hereby authorized and directed to publish notice of said public hearing in The Daily Mail, a newspaper having a general circulation in the Town and hereby designated as the official newspaper of the Town for such publication, on or before October 26, 2020, which is not less than ten (10) days prior to the date of the said public hearing.
